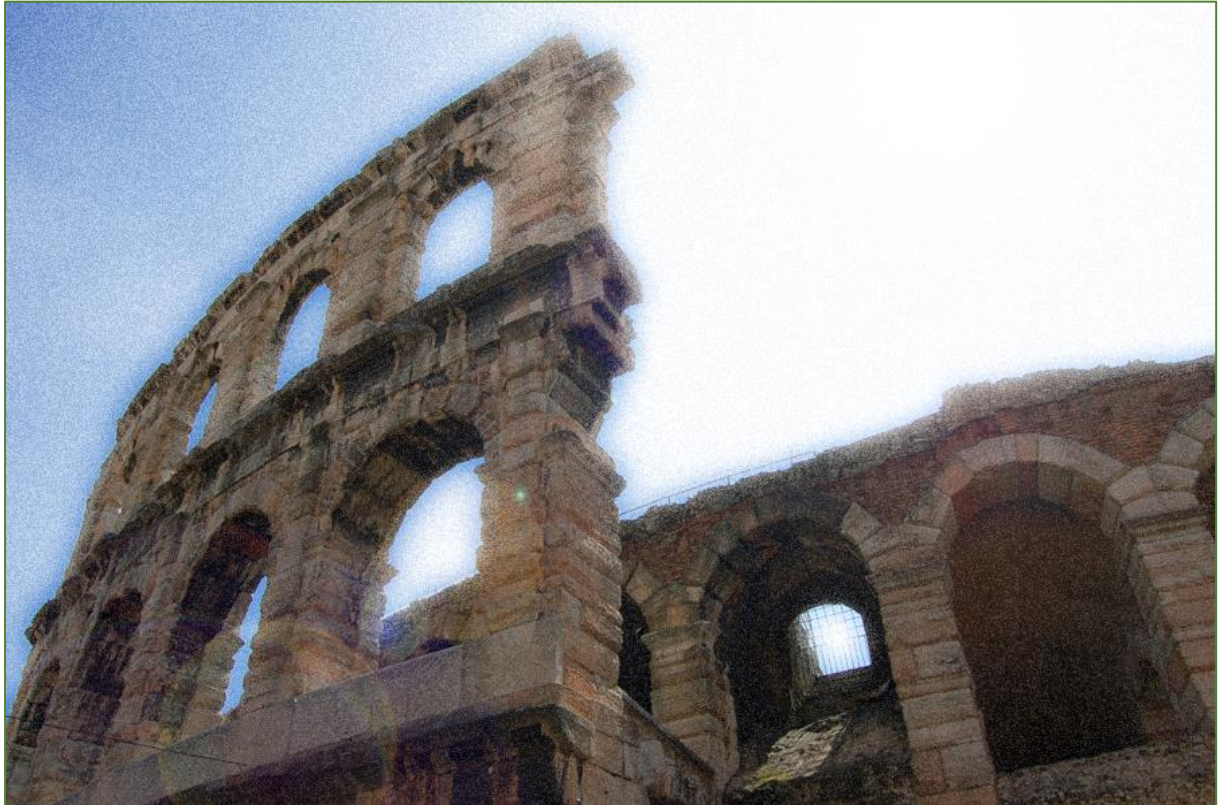

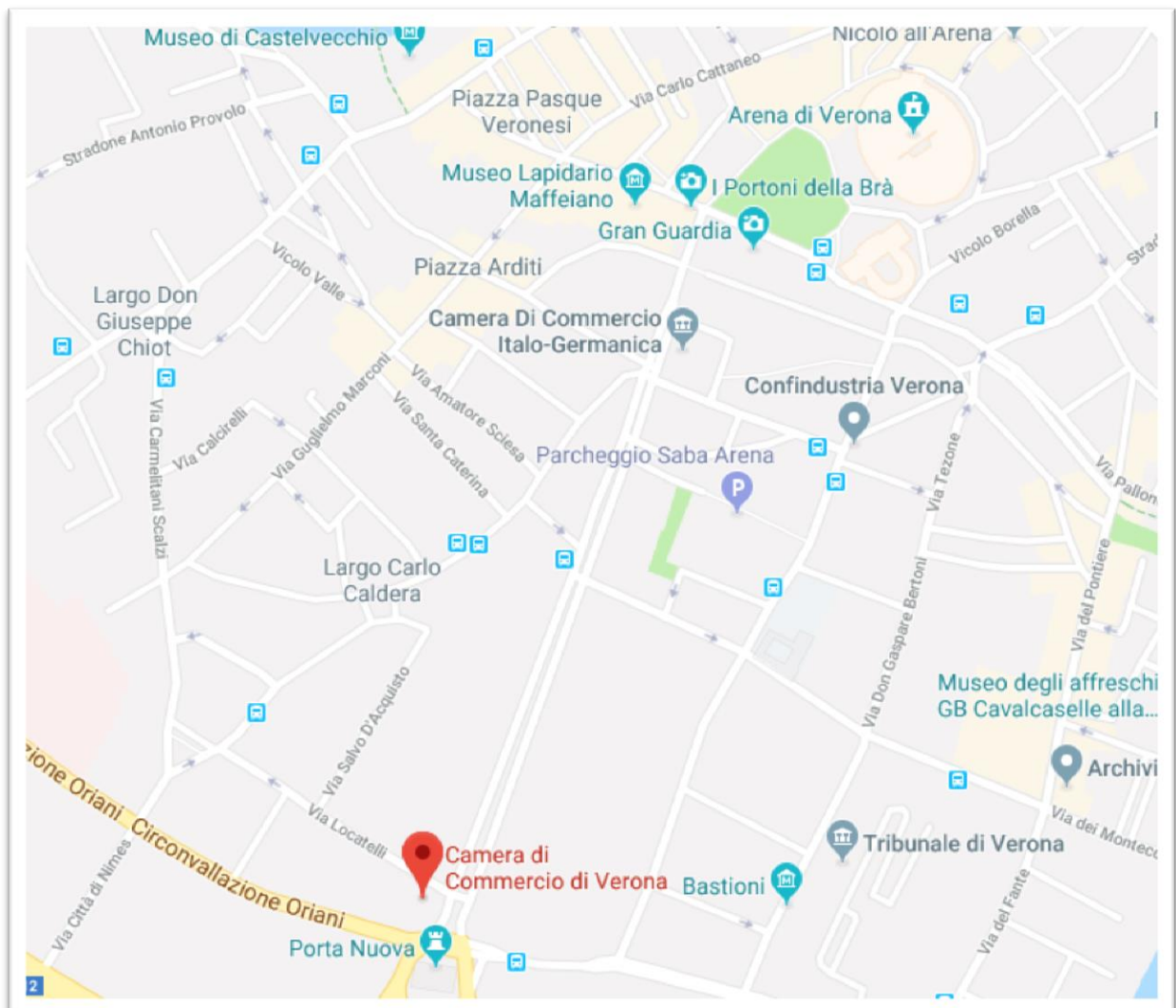

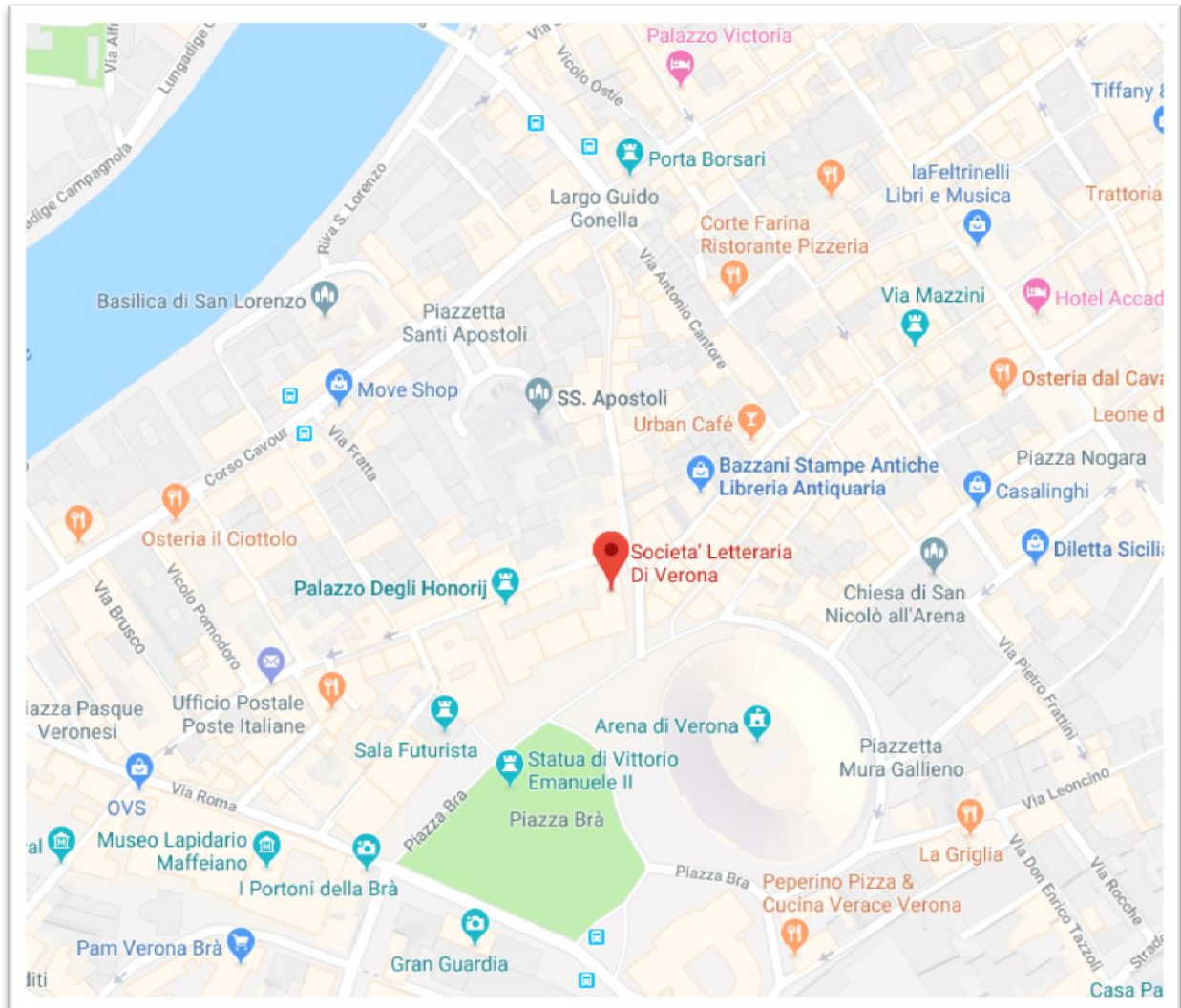

- ❖ Verona **Taxi Service** – phone +39 045 532666 – [Rates](#)
- ❖ If you arrive **by train**: walking distance from Porta Nuova station to downtown - seminar venue on Friday: 5 mins. Walking distance to Saturday's meeting venue: 20 mins.
- ❖ If you arrive **by plane**: from the Verona-Villafranca airport to downtown by taxi it takes about 15 minutes.

- ❖ If you are **driving**: the meetings' venues are all close to the heart of Verona. (Limited Traffic Zone). If you are driving, free transit access from Monday to Friday : 10.00 – 13.30 / 16.00-18:00/ 20.00 – 22.00. Saturdays, Sundays, bank holidays : 10.00 – 13.30.

From November 8th to 10th we have agreed the following preferential rates:

- Classic single room (bed size: 110 cm) euro 100,00 (rooms available: 10);
